CIRCLE R RODEO UNCHANGED, CRUEL AS EVER There has been a lot of pressure on the local rodeo operation known as the Circle R Rodeo this summer. Despite the fact that several obvious animal abuses were cited by WMFA members, the rodeo has done nothing to change those violations. In fact, several members attended the rodeo and found more severe forms of cruelty! On Saturday, August 20, there were no water buckets in the animals' pens (except for the sheep), absolutely no shade, a calf and a bull smashed into one of the chute gates, causing severe disorientation, and an apache horse had large, open bleeding wounds on his sides. It seems that the Circle R Rodeo simply does not care how their animals are treated so long as the "bucks" are rolling in.

Despite the gloomy forecast, all is not so terrible. As a result of continued protests, five businesses have withdrawn their sponsorship. They were disgusted that their dollars were funding something So cruel. Most other business that sponsor were polite and did listen to what we had to day. And Herb, Cole and Wendy distributed anti-rodeo literature in Cedar Springs on August 12.

Vanderhyde Ford talked at length with WMFA members and were interested in what we had to say, however Muc Autobody did call the police. An officer who had anti-rodeo literature in her cruiser stated that the activists had not broken any laws and were able to remain and leaflet.

If protests are kept up with this kind of vigor, we may see the end of the Circle R Rodeo once and for all. How fortunate for the animals that would be. COMMITTEE HELP

It was stated that \$2000 is what they "loaned" at this time. \$2000 is an inaccurate amount at this time, \$3500 is a more accurate estimation at this time belonging to WMFA as a whole. It is a fact that the funds were raised as a group effort through group activities such as the dog washes, etc. Not out of the pockets of those former members. It is also a fact that WMFA has been in existance since as a corporation and not as a loose association of 4-5 years.

Robin Cleaves, Interim Vice President, informed Tolley Vandenbosch and Walton, The opposing law firm, that all money was raised in the name of WMFA and belongs to the group as well as all documents literature, equipment etc. This can and will be proven in District Court. She asked for written resignation from the former members/their clients. It has been informed that legal action will be taken if corporate money has been deposited into personal accounts. We can and will present legal evidence of the above items and that all is factual and if any further falsehoods are made we will alert the news media as to what their clients are doing to tarnish the good name of West Mich. for Animals.

A letter of apology was written to Pet Supplies Plusfor the falsehoods told to that company by the former members. They told Pet Supplies Plus that WMFA was dissolved and that the group left over was to wage a demonstration against the store. Also that the dog washes were cancelled indefinately. Hopefully this situation has been resolved since Pet Supplies Plus is our most beneficial sponsor and has done more than enough to help our organization.

"MEATY, BEEFY AND BOUNCY Leaner cuts and positive PR have cinched the rebound of beef, which is enjoying it's largest per-capita consumption increase in a decade. Beef eaters scarfed down 63.7 pounds each in 1994 up to a 3.7 percent increase from 1993.

Industry forecasters predict the per-person poundage will rise to 64.8 this year and to 65.8 pounds in 1996.

WMFA has called for demonstrating 3 days before the Sparta Rodeo. People
should park downtown and meet at WM Rodgers Park, N. State Street at 12:30 pm.
We will march through town and protests before the 2:00 pm start of the Klein
Rodeo. WMFA has been monitering this rodeo for 10 years and it has a long
list of documented county anti-cruelty violations and witnessed stock animal abuse.
Currently, legal effors to get Klein to comply are stymied until we have
knowledge of how to sue in circuit court for injunctive relief to force him to
comply with the regulations.

Also, along with the list of Grattan Circle R Rodeo sponsors, persons are asked to call and complain to sponsors about the cruelties that occur in both rodeos. Call Herb at 459-1982 or Cole at 785-0102 to get the list and let be heard!!

DOVE HUNTING BILL ON THE BORDER NOW

The pro hunting community is working over time to get SB 529 passed to legalize the hunting of Mourning doves in the state of Michigan. Unfortunately the bill passed the Senate before the legislature began it's Summer recess in late May. The bill is now in the House Conservation Committee, whose Chairman, Rep Mick Middaugh R-Paw Paw, must make the decision to bring it to a vote. Please call Rep. Middaugh at (517) 373-0893 and tell him you oppose dove hunting. We must enact a counter measure since Michigan Outdoors launched a campaign to encourage hunters to call him and voice their approval.

According to Michigan Outdoors, "Doves are the most abundant game bird in the United States...There is, in short, no logical reason why doves shouldn't be hunted in Michigan." Doves are currently legally hunted in 37 states.in the u.s.

The Detroit Audubon Society, Michigan Audubon Society and the Michigan Humane Society have joined forces with the Fund For Animals to defeat SB 529. If this fails, dove hunting will be legal in Michigan by 1996. This simply cannot be allowed to happen. Please write your representatives and voice your opinion on SB 529 As soon as possible.
