Support the European Ban on Importing Leghold-Trapped Fur

The Chancellor Of Germany, Helmut Kohl, has been given a tour of rural Canada (home to most trappers) in an attempt to win his support for the dismantling of the European Union's ban on furs from animals caught in leghold traps. As usual, those with an interest in permoting the drowning, beating, and trapping of animals for their fur will stop at nothing to sell their furs to Europe.

In an attempt to win Mr. Kohl's support, he was given a tour of native communities who the Government of Canada says, need trapping to survive. It is not surprising that Mr. Kohl did not meet those native groups opposed to trapping, including Native Animal Brotherhood who question why the Government of Canada believes that the only way of life for natives people is trapping & skinning animals.

Please write to Mr. Kohl & let him know that as a North American you support the ban on furs from animals caught in leghold traps into Europe.

DOVE HUNTING BILL SHOT DOWN IN MID-FLIGHT

(Excerpts from The Detroit News)

The controversial dove hunting legislation introduced last May by Senator Philip Hoffman, R-Horton, has been soundly defeated. Despite the Michigan United Conservation Clubs' claim that dove hunting is "a wholesome sport," the mourning dove will continue to enjoy its status as a protected songbird in Michigan instead of being reclassified as a game bird.

Paw, Chairman of the House Conservation, Environment, and Great Lakes Committee, has been besieged by 5,275 calls, letters, and postcards on the issue. 92% of those mmunications represented opposition to a dove hunting season in Michigan. Himself a hunter, Middaugh, said, "I've never seen anything like this in my seven terms in the legislature. I think it's clear [that] there is not a great deal of support for this, even among some callers and writers who identify themselves as

A poll of 600 Michigan voters found that 54% are opposed to the measure while 28% support it. The rest are undecided.

On September 22nd, a press release was issued from Representative Middaugh's office. In it he stated that, "The people have made their views crystal clear. Many interest groups have been involved in lobbying the legislature, but the people of Michigan, who overwhelmingly said NO to dove hunting, are the ones who influenced the final decision."

PHARMACEUTICAL COMPANY: CRUEL & DIRTY

Wyeth-Ayerst Pharmaceutical Company manufactures the hormone, Premarin, which is used as a post-menopausal drug and in some oral contraceptives.

Premarin is made with the urine of pregnant mares. The horses are kept pregnant year round so they will produce estrogen which is excreted in the urine. They are confined to extremely small stalls and fitted with catheters. The catheter bags chafe the mares' legs to the point of leaving bloody, raw, open scres. The horses are not allowed freedom. They bear foal after foal. When they can no longer be kept pregnant, they are slaughtered.

You can voice you opposition to this appalling cruelty. Please call Wyeth-Ayerst at 1-800-999-9384. If you take Premarin, discuss other options with your doctor. There are synthetic hormones such as OgEn available. Most doctors are usually cooperative in changing prescriptions when made aware that the primary ingredient in Premarin is horse urine.

IPAMIONS" PROCTOR & GAMBLE DEMOS

At this time, we don't have any information regarding the recent demonstrations at Proctor and Gamble' Annual Shareholders' Meeting. We do know that West Michigan was represented by Kalamazoo Animal Liberation League (KALL) who handed out literature on October 10.

The public has been asked to boycott P&G due to their continued policies of animal testing for various products. In Defense of Animals had asked that the public send P&G coupons to them so they could be presented to the management at P&G's Shareholders' Meeting to demonstrate the strength of the boycott.

It's not too late to help. Please continue to clip P&G coupons, but Don't use them! Send them back to Proctor and Gamble with "Boycott companies that test on animals" written across them. Sooner or later, through public pressure, Proctor and Gamble will be forced to join such companies as Dial, Revlon, Avon, Benneton, and Neutrogena, and STOP THE ANIMAL TESTING!

EU Ban on Trapped Animal Fur Needs Your Support

Representatives from the fur trade along with specialinterest favoring government officials in the US and Canada, are pulling out all stops in a last-ditch attempt to prossure the European Union (EU) to back down on the pending ban on leghold trapped animal fur, scheduled to take effect January 1996. Letters and faves are desperately needed now to key decision makers to urge them not to cave into pressure from a minority of special interest groups.

Regulation 3254/91, passed by the EU in 1991, will ban fur imports from countries still using the leghold traps as of January unless the trap is outlawed or an alternative trapping method deemed "humane" is approved. Although more than 65 countries have barned the leghold trap, it is still the most widely used trap in the United States and Canada, causing agonizing death for millions of animals each year. Animals caught in leghold traps may suffer in terror for days and will sometimes chew off their own feet to escape. Since these traps cannot be selective, "nontarget" victims such as endangered species or pets, considered "trash animals" can get caught in the trap's steel jaws. For those who do not freeze to death or become the defenseless victim of another predator, they will find their fate when the trapper returns to "finish the job" by strangulation, bludgeoning, or shooting,

The ban was originally scheduled to go into effect January 1995. But, pressure from the fur industry caused a postponement until January 1996. Because Europeans purchase from 70% to 80% of American furs, it is easy to see why this Regulation is so vitally important to animals in this country. The effects could be tremendous. Millions could be spared agonizing death. What you can do:

This ban is in jeopardy of being delayed, if the wellfinanced minority of fur trade representatives get their way. Letters are urgently needed now to:

Mr. Jacques Santer, President of the European Commission: (Mr. Jacques Santer, President, European Commission, 35/45 Ave. d'Auderghenn, Brussels, Belgium 1048, Fax: 32-2-295-5009). Urge the Commissioner not to further delay implementation of Regulation 3254/91. Let him know that according to a Yale University study, 78% of Americans oppose the use of leghold traps altogether. Convey to him that Americans support the European peoples courageous and historic stand to stop leghold suffering and cruelty and that the Regulation should be implemented in January of 1996.

US Trade Representative Mickey Kantor: (Ambassador Mickey Kantor, US Trade Representative, Executive Office of the President, Washington, DC, 20506) Ambassador Kantor is opposing the European Regulation. Tell him that it is time the US joined the rest of the civilized world and banned the leghold trap in our own country. It is reported that Kantor is bowing down to fur industry pressure and joining Canadian international trade minister Malcolm McLaren in declaring the Regulation 'an unfair trading practice' under GATT provisions. Both trade ministers have threatened to challenge the Regulation through the World Trade Organization (the governing body of the GATT) if it goes through. Tell Mr. Kantor that the great majority of Americans support the ban and that it was overwhelmingly passed in 1991 by the European Parliament, the Commission, and the Council because of strong public demands to prevent the agony animals suffer in these cruel traps. Urge him not to file a GATT action against this enlightened European Regulation.

Letters are also needed to your Congressional representatives (Your Representative, House of Representatives, Washington, DC 20515; Your Senator, US Senate, Washington, DC 20515). Urge your members of Congress to tell Ambassador Kantor to stop opposing European Regulation No. 3254/91. Tell them the United States will be disgraced if Ambassador Kantor succeeds in his opposition. (And while you're writing to your Representatives, urge them to co-spensor H.R. 1404 which would prohibit the steel-jew leghold trap-nationwide').

Write your letters today! Tomorrow may be too late.
